



TOWN PARK SHELTER(S) /FIELD USE AND AUTHORIZATION

Official business of legally constituted Town Governmental units will take precedence over all other uses of Town Buildings and properties.

Person and Organizations Eligible to reserve Town Park

- a) Residents of the Town of Wales**
- b) Organizations of the Towns**
- c) Outside organizations**

REGULATIONS FOR RESERVING TOWN PARK SHELTER(S)/FIELD

- 1) All parties wishing to use the Shelter(s)/Field must file with the Town Clerk in writing.**
- 2) The party/individual reserving the Shelter(s)/Field is responsible for:**
 - a) Any damages to the Shelter(s)/Field after**
 - b) The general condition of the Shelter(s)/Field after use (i.e. placement of times to original position/condition, trash, remove person effects.)**
- 3) No glass bottles allowed in the Shelter(s)/Field,**
- 4) Trash is to be carried out with you.**
- 5) All functions to end and Shelter(s)/Field cleared by 10:00 pm.**
- 6) Noise and lights will be reasonable so as not to cause annoyance to neighbors.**
